Dear Friends,

First of all we would like to thank those who supported us. The 5th WKC World Championship of Fortaleza has been a great success: 25 federations participated in the competition, 14 attended the Congress held on Wednesday 22nd June, when unfortunately not all nations had arrived in Brazil yet. The competition was characterized by a strong correctness. The technical level is continuing to grow. 301 athletes, 55 teams, 46 referees, 29 coaches participated in this event. Here are the results:

FORTALEZA, BRAZIL, 22nd June 2005
Hotel Ponta Mar, 16.00 o'clock**

Present WKC Founding Members Carlo Henke and Demetrio Donati
There delegates of: England, North Ireland and Ireland were absent.

2. Opening of the Congress

The Chairman, Mr. Carlo Henke, opened the Congress with the President of the Organizing Committee, Mr. Osvaldo Messias de Oliveira, the Vice-President Mr. Nestor Parreno and the Treasurer, Mr. Angel M. Duato.

After the official welcome, Chairman Carlo Henke presented the actual political situation of WKC, the fact that there are two federations having the same name. Carlo Henke gave the speech to Osvaldo Messias for official presentation of the 5th Championship with the participation of 24 organizations with 301 competitors and 55 teams from different continents, America, Africa, Europe.

It is important to consider the problem of receiving visa for some federations from Asia like India, Pakistan and Nepal that could not attend the championship.

Osvaldo Messias stated the problems in organizing the championship due to the intimidation letters of the other WKC organization. In the final all the authorities sustained the championship. With the support of Carlo Henke, the championship is ready to start.

The Chairman recalled to the delegates the brave history of WKC in the last two years and the big problems created by the illegal Congress in Belgrade and the dictatorial system promoted by the other "WKC" organization. Carlo Henke presented four persons that supported the organization in the last 6 months: Dr. Liviu Crisan, Romania, Lawyer Roberto Bani, Italy, Enrique Silva, Portugal and Dr. Spartaco Bertoletti, Italy.

Dr. Liviu Crisan presented the "history of WKC in the last two years" with the strong evidence of illegality and no-democratic application of the Statute by the President of WKC.

Lawyer of WKC, Roberto Bani, introduced the official memory deposited in the Court of Milan where WKC is registered for demonstrating that the Congress in Belgrade is the clear violation of the WKC Statute in every point.

Chairman Carlo Henke reported the situation that now there are two WKC organizations and it is not possible to turn back because the other organization has tried to boycott the championship and tried to destroy the name and the personality of the organizer, Mr. Osvaldo Mesias de Oliveira.

3. New Statute of WKC

Mr. Carlo Henke introduced the new statute sent to every organization on January 2005. The adoption of the new statute was voted by 14 delegates plus 3 votes for Founding Member, Carlo Henke and 3 votes for Founding Member, Demetrio Donati.

The statute was voted unanimously.

4. Elections

The list of candidates was presented to the delegates at the first and the persons that applied for the Executive Committee positions had presented themselves.

Before the opening of the election list, Mr. Rolf (Switzerland) proposed that Chairman Henke has to remain in the leading position of President at least 1 year. Mr. Osvaldo Messias de Oliveira declared that he sustains this proposal and he will renounce at his candidature.

Chairman Henke declared that *"I shall not go out from the door and come back through the window"* so he firmly refused this proposal and declared that his opinion is that Mr. Osvaldo Messias de Oliveira is the best President for the democratic body.

The voting with the new statute, by secret ballot, produced the following results:

President: Osvaldo Messias de Oliveira 12 votes

1st Vice-president: Henrique Laranjo Silva 11 votes Chief Referee
Commission

2nd Vice-president: Nestor Parreno 11 votes

3rd Vice-president: Roberto Bani 11 votes Lawyer of Wuko

4th Vice-president: Angel Martinez Duato 10 votes Treasurer

5th Vice-president: Liviu Crisan 10 votes Secretary

There were 2 abstentions. For democratic reasons founding members refused to use their vote.

5. The decisions of the new Executive Committee were:

- a. President Osvaldo Messias proposed as Honorary President and coordinator Mr. Carlo Henke. There was a unanimous approval of this proposal;
- b. at the next World Championship at Cluj Napoca, 2006, a list of 5 auditors will be established;
- c. the European Championship will take place in Barcelona, Austria or Belgium in 2006;
- d. the World Championship, 2007, will take place in Valencia;
- e. the 6th vice-president will be elected in Cluj Napoca;
- f. Mr. Steve Elers (New Zealand) was nominated as Chairman for Oceania continent;
- g. Mr. Koos Burger (South Africa) was nominated as Chairman for Africa continent.

6. The future of WKC

Mr. Carlo Henke, in this moment only President of the Congress, proposed to change the name of the organization, because the court process could take several years to resolve, (for example: JKA in Japan) and it is very difficult to promote the organization when another group has the same name and logo.

Also the Congress decided that sending letters for blocking the activity of the other WKC is not a good way, because this could destroy the image of Karate-Do.

Carlo Henke proposed to come back in the past and adopt the name of World Union of Karate-Do Organizations (WUKO) in other words to found again the prestigious WUKO and save Karate from other matters of envy, game of power and money.

This proposal was voted by 14 delegates, 1 of them abstained and 1 (Swiss delegate) absent.

At 7.30 p.m. the Congress was finished and start the 5th World Championship of WKC.

WUKO DIRECTING COMMITTEE, 27th June 2005

The first meeting of the WUKO Directing Committee took place at the Hotel Ponta Mar, in Fortaleza. The main points discussed and deliberated are:

1. President Osvaldo Messias de Oliveira expressed his satisfaction for the re-foundation of WUKO, a truly democratic organization in which each Member has 1 only vote.
2. The Treasurer, Mr Angel Martinez Duato, reported the new fees, reduced of almost 30%, they have been accepted positively by the WKC members. Treasurer recommends to the President and to the WUKO-Dc a strict control of expenses, in consideration of the reduction of fees.
3. It has been established to introduce kumite for children category, 6 to 14 years, who will compete using protective helmets with visor in hard plastic and protections for the body. The person responsible for refereeing, Mr Henrique Laranjo Silva, is charged to propose to the WUKO-Dc the categories of age and grade for the next World Championship scheduled in 2006 in Romania.
4. Weight categories of Junior and Senior, for safety reasons, will be led from 3 to 5. The "Cadets" category, 15-16-17 years old, is introduced.
5. It will be introduced the "Rengokai" category into kata competitions. In this category will compete all styles that will not reach at least 4 participants (from minimum 2 different nations).
6. Continental Championships of WUKO will receive the 75% of competition fees that will be collected, while the 25% will go to the WUKO central body. Regulations will be issued as soon as possible.
7. Honorary President Carlo Henke thanks for the appointment of WUKO representative at the IOC, International Olympic Committee, and asked to the Directing Committee to leave open the participation of all WUKO Members to the competitions promoted by other organizations: *"A democratic Federation with a glorious historical past like WUKO is, cannot fear any competitions. On the contrary, it's good that our members take part in competitions organized by other organizations, so they can realize the difference that exists between ours and the other federations"*. The WUKO-Dc approved the proposal.

WUKO MAGAZINE

At the end of every World Championship, WUKO will send to its Members the "*WUKO Magazine*", an insert of 8 pages in colour with the description of the event and the most beautiful photos of the Championship. All the WUKO Members are invited to contribute with photos and news for a publication that can be repeated periodically.
